**I. AVAILABILITY:**

This rate is available to consumers for service to pivot drive irrigation services when the pump is operated with fossil fuel, subject to the District's Service Rules and Regulations.

**II. TYPE OF SERVICE:**

Single or three phase, 60 hertz, at available secondary voltages.

**III. RATE:**

Horsepower (HP) Charge:

No Control Rate (service not interrupted)	\$61.00 per Hp per year
Standby Rate (service not used during the months of June thru September)	\$18.36 per Hp per year

The horsepower for billing purposes shall be the manufacturer's nameplate rating.

Energy Charge:

All kWh of usage	13.00 cents per kWh
------------------	---------------------

The minimum annual charge for this type of service shall be the greater of \$256.20 per year for a single phase service and \$393.00 per year for a three phase service; or the horsepower charge as determined in accordance with the foregoing rates; or the amount specified in the Agreement for Service.

Energy (kWh) charges along with horsepower charges as determined in accordance with the foregoing rates will be combined to determine whether or not the consumer has met the obligation for the annual minimum charge.

**IV. BILLING:**

Horsepower charges will be billed in May. Energy used after the previous billing period may also be billed in May if that information is available. Otherwise, energy charges will be billed at the end of the year.

V. **TERMS OF PAYMENT:**

Bills are due and payable upon receipt and delinquent at the end of the month received, or as specified on the bill.

VI. **POWER COST ADJUSTMENT:**

The energy charge provided herein may be adjusted in direct proportion to the production cost adjustment applied to wholesale power purchases, increased by the District's percent system loss the previous calendar year.

VII. **TAX CLAUSE:**

The rate provided herein will be adjusted to reflect the amount of taxes, license fees, franchise fees and/or any statutory payments required by law.

VIII. **SUPERSEDES:**

This rate schedule supersedes and cancels all rate schedules with which it may be in conflict.
